











Fiscal Year 2022 THUD Budget








Surface Trans. Reauthorization






















# State of bipartisan infrastructure negotiations


- White House, Senate agree to bipartisan framework for \$547 billion, 5-year infrastructure bill
- Disagreement remains on whether to link to broader Budget Reconciliation
- Diverse set of pay-fors; not user fee-based








Fiscal Year 2022 THUD Budget

# INVEST Act - Next steps

 House taking up H.R. 3684 today, with several amendments Rail Passengers is tracking

#### **SUPPORT**

- 67. Moulton (MA) #15 Increases the PRIME program funding by \$1 billion in each of fiscal years 2022 through 2026, for a total increase of \$5 billion.
- 99. Titus (NV) #55 Amends RRIF program to add HSR activities under the eligible entities for credit risk premium subsidy payments.

#### **OPPOSE**

- 6. Brady (TX) #251 Revises RRIF program to add new conditions for loans.
- 70. Nehls (TX) #30 Strikes Division D of the bill (rail title)
- 80. Perry (PA) #144 Prohibits the use of funds for Amtrak Network Expansion.
- 97. Suozzi (NY) #188 (REVISED) Establishes a North Atlantic Rail Interstate Compact

# INVEST Act - Next steps

- Senate will (hopefully) take up S.2016 in late July
- The two different versions will need to be reconciled as part of a larger bill before September 30
- Questions remain about how the surface transportation authorization will fit with the infrastructure bill and Budget Reconciliation




